CITIZENS SHERIFF'S ACADEMY

Some of the topics that will be discussed:

History and Information about the Spalding County Sheriff's Office

Participants are introduced to the Sheriff's Academy Staff and fellow classmates. The Sheriff and Command Staff are introduced. A brief history of our office will be presented by the Sheriff along with information about budgeting, Office of Professional Standards, and Internal Affairs.

Traffic Enforcement and Patrol Function

Participants are introduced to the Georgia Motor Vehicle Law. Other topics that are presented will include traffic direction, RADAR/LASER, vehicle pullovers, officer safety, vehicle pursuits, and functions of the Uniform Patrol Division.

Criminal Investigations and Crime Scene Processing

Members of the Criminal Investigation Division will present this course. Participants will be exposed to criminal law, the structure of the Investigative Division, interview techniques, investigative tactics, and available resources. Techniques for crime scene processing and evidence gathering are discussed. Participants will conduct a practical exercise processing a mock crime scene. Investigators will present an overview of procedures for dealing with the special needs and responsibilities relating to the arrest and processing of juvenile offenders.

Special Operations, K-9 Program, Criminal Street Gangs, and C.A.G.E. Unit

Participants will be introduced to the different drugs that affect our community. Topics included will be drug recognition and intervention programs. The class will be supplemented by a variety of visual aids and demonstrations. Investigators tasked with investigating and documenting participants in criminal street gang activity will present information centered on the gang problem, gang history, and gang issues as they affect us on a local level.

Courts, Civil Processes, and the Criminal Justice System

During this presentation students will get a first-hand view of the criminal process from the initial call the officer receives, arrests, hearings, trial, and final case disposition. The role of the Sheriff's Office in the Civil Process will be discussed.

Internal Affairs and Ethics in Law Enforcement

Students will learn how internal affairs investigations are conducted, and what leads to an internal affairs investigation. Students will learn the process of filing a complaint on a Deputy and the steps taken after their complaint is filed. Law enforcement ethics will be discussed in an open forum in which students will be encouraged to ask questions and discuss issues.

Response to Aggression

Laws regarding use of force and options in use of force will be discussed. Students will view and discuss video recordings of use of force incidents and their outcomes. "Force on Force" training will be utilized during this section of the academy. This training will place participants in shoot-don't shoot situations using role players. Students are also introduced to the use of force continuum, and case law regarding use of force.

Search and Seizure

Students will be presented with information regarding search and seizure, search warrants, searches that require warrants, various types of warrantless searches, vehicle searches, the results of unlawful searches.

SWAT, 911 Center, and Special Operations

Special Response Team Members of the Spalding County Sheriff's Office will discuss their responsibilities and tactical operations abilities. Participants will perform practical exercises such as room clearing, searching rooms and buildings, and responding to crimes in progress. Participants will be given a tour of the communications center and will see how emergency calls are received, processed and dispatched.

Firearms Training

Attendees will participate in both classroom and live-fire training held at the Shoal Creek Firing Range. This portion of the class is hands on and will allow students to participate in live fire, and see demonstrations of various weapons and body armor.

- 4. Bring greater support to our Sheriff's Office by giving the citizens an understanding of what our roles are as Deputy Sheriffs.

- 1. Please complete and return the attached Application for Enrollment and waiver/release forms in its entirety. Class members must be at least 18 years of age. Acceptance of applicants is at the discretion of the Spalding County Sheriff's Office.
- 2. All applicants will be subject to a criminal history check as a precondition to acceptance into the academy. The deadline for the return of the application package is July 30, 2021. Return complete application package in person to the Sheriff's Office front office, or e-mail to wstinchcomb@spaldingcounty.com.
- 3. The Sheriff or his designee has final approval of all applicants and reserves the right to deny entry to any applicant. Accepted applicants will be notified by email.
- 4. The academy is free of charge to all members. Class size is limited to the first thirty (30) people.
- 5. Dress for class is casual. Name badges will be provided and should be worn to class.
- 6. Qualified applicants who are denied admission due to class size will be given first choice when the next academy session is scheduled.
- 7. The Release of Liability Statement form must be signed and turned in by the applicant with the completed application.
- 8. The classes will be held in the training room of the Sheriff's Office located at 401 Justice Blvd. Griffin, Georgia.
- 9. Classes will be held on Tuesday evenings from 6:00 p.m. to 9:00 p.m.
- 10. For those of you that enjoy smoking, a designated smoking area will be available during the scheduled breaks.

CITIZENS SHERIFF'S ACADEMY GCIC AWARENESS STATEMENT

Access to Criminal Justice Information, as defined in GCIC Council Rule 140-1-.02 (amended), and dissemination of such information are governed by state and federal laws and by GCIC Council Rules. Criminal Justice Information cannot be accessed or disseminated by any employee except as directed by superiors and as authorized by approved standard operating procedures, which are based on controlling state and federal laws, relevant federal regulations, and the Rules of the GCIC Council.

O.C.G.A. 35-3-38 establishes criminal penalties for specific offences involving obtaining, using, or disseminating criminal history record information except as permitted by law. The same statue establishes criminal penalties for disclosing or attempting to disclose techniques or methods employed to ensure the security and privacy of information or data contained in Georgia criminal justice information systems.

The Georgia Computer Systems Protection Act (O.C.G.A. 16-9-90 et seq.) provides for the protection of public and private sector computer systems, including communications links to such computer systems. The Act establishes four criminal offences, all major felonies for violations of the Act: Computer Theft, Computer Trespass, Computer Invasion of Privacy and Computer Forgery. The criminal penalties for each offense carry maximum sentences of 15 years in prison and/or fines up to \$50,000, as well as possible civil ramifications. The act also establishes Computer Password Disclosure as a criminal offense with penalties of one year in prison and/or a \$5,000 fine.

The Georgia Justice Information System (CJIS) Network is operated by the Georgia Crime Information Center in compliance with O.C.G.A. 35-3-31. The Computer Systems Protection Act protects all databases accessible via CJIS Network terminals. Similar communications and computer systems operated by municipal/county governments are also protected by the Act.
